

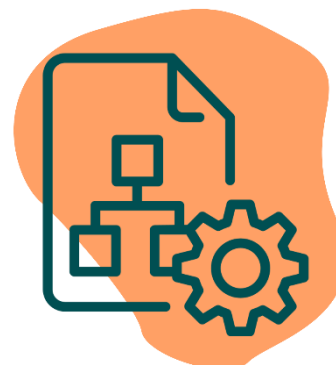
The purpose of this document is to give an overview over the changes implemented on the criteria level on 28. September 2023 on [Siegelklarheit.de](https://www.siegelklarheit.de). This includes adjustments on the credibility requirements, applicable to all product groups, and on the requirements for the product group textiles.

I. Credibility Criteria

The complete set of the credibility criteria was revised in 2020-2021 to ensure that it reflects new technical, social and political developments. Part of that revision process was an expert review conducted by the International Social and Environmental Accreditation and Labelling Alliance (ISEAL Alliance) and Assurance Services International (ASI) as well as two consecutive public consultation rounds.



The steering committee of Siegelklarheit, coordinated by the Federal Ministry for Economic Development and Cooperation (BMZ), approved the minimum requirements in July 2021. In a final step, the revised criteria were harmonized with the database of the International Trade Centre (ITC).

The **objective** of the revision was to

- Reflect recent developments and innovations
- Ensure applicability and continued relevance
- Raise level of ambition
- Clarify language of requirements

Before the revision, the credibility criteria consisted of 101 criteria, including 18 minimum requirements (MiK). After revision there are now **87 criteria in total including 23 minimum requirements**. After a transitional period, the level of ambition will be raised again in March 2025. The following will give an overview of the most significant changes:

a. Minimum Requirements

- 6 new minimum requirements were added and implemented in September 2023.
- 5 criteria will become minimum requirements in March 2025.
- For 4 already established minimum requirements, the level of ambition (Degree of Intensity) will be raised in March 2025.

b. Overall Criteria Set

Changes were also made to the overall criteria set for credibility. These include changes in order to streamline the criteria set, thus deleting or merging selected criteria. Furthermore, several criteria were added to address specific topics. The following gives an overview over the most significant changes:

II. Product Group Textiles

a. Minimum Requirements

In 2018/2019, the **minimum requirements** for the product group textiles were revised in a public consultation process with an expert review conducted by Oeko Institute, Hessnatur Foundation and FEMNET e.V.



The steering committee of Siegelklarheit, coordinated by the Federal Ministry for Economic Development and Cooperation (BMZ), approved the minimum requirements in July 2021. In a final step, the revised criteria were harmonized with the database of the International Trade Centre (ITC).

The **objective** of the revision was to

- Reflect recent developments and innovations in the sector
- Ensure applicability and continued relevance
- Raise level of ambition
- Clarify language of requirements

Before the revision, the product group textiles counted 17 minimum requirements combined in the dimension environmental friendliness and social responsibility. After the revision the total number of minimum requirements increased to 34. The following will give an overview of the most significant changes:

- 16 new minimum requirements were added
- For 2 of those requirements, the level of ambition (Degree of Intensity) will be raised in March 2025

b. Overall Criteria Set

The criteria set furthermore consists of additional requirements which are used for the overall assessment. In both dimensions, environmental friendliness and social responsibility, 6 criteria respectively were added to address important topics more comprehensively. These changes are based on recommendations of an expert review conducted by the Proforest Initiative.

E37	Use of Chlorine Gas	Does the standard include criteria on the use of chlorine gas, elemental chlorine, chloroorganic compounds as bleaching agent?
